# DELIVERY PASS BENEFIT TERMS AND CONDITIONS FOR THE WALMART REWARDS MASTERCARD ISSUED BY FAIRSTONE BANK OF CANADA

## Summary of the annual Walmart Delivery Pass subscription benefit terms and conditions

These terms and conditions apply to the Walmart Rewards Mastercard and annual Delivery Pass subscription benefit.

#### Overview

- 1° Sign up for or renew a regularly priced annual Walmart Delivery Pass subscription on or after September 18, 2025, at Walmart.ca or through the Walmart Canada Mobile App.
- 2° Pay with your Walmart Rewards Mastercard and receive:
  - Walmart Rewards Mastercard: a statement credit equal to 3 months of Delivery Pass fees (plus taxes); or
  - Walmart Rewards World Mastercard: a statement credit equal to 6 months of Delivery Pass fees (plus taxes).
- 3° Get the same 3- or 6-month statement credit every year when your pass auto-renews, as long as you keep using your Walmart Rewards Mastercard.

#### **Benefit**

Beginning September 18, 2025, a regularly priced annual Walmart Delivery Pass subscription purchased or renewed online at Walmart.ca or via the Walmart Canada Mobile App with an eligible Walmart Rewards Mastercard qualifies for a statement credit equal to:
